In the beginning of the meeting the ADWO welcomed all the members including the Chairman and discussed elaborately about the objective of the SDLC meeting.

The Chairman discussed about the return back of 11 numbers CFR/CFRR cases from the D.W.O, Balasore as per consent of the ACF, Balasore. Out of objected 11 no. cases, one case record relating to Naranpur village under Naranpur G.P. was rectified by the concerned FRC covering all the quarries raised by the ACF, Balasore for discussion and approval in the meeting. But the ACF, Balasore pointed out that as per the norms and condition of the Rule-2006 and 2012 the claimants under CFR/CFRR do not physically reside over the forest land which they claim to be settled in their name. Even in Nilgiri area, the claim forms received under CFR/CFRR, only the beneficiaries who availed title under FRC are entitled to claim rights under CFR/CFRR same nature as stated above. After discussion, it is cleared that all 82 no's .of claim forms under CFR/CFRR received are not eligible to be approved, which are contrary to the provisions under the Forest Right Act, that they are residing outside forest land, which they have claimed.

The WEO, Oupada pointed out that 86 no's of individual cases are pending for joint verification which relates to Pratapada and Ranipokhari village under Oupada Block. In this regard the chairman and ACF, Balasore advised that the application of claimants are to be verified by the concerned Tahasildar, whether they residing in any




Forest Land/ availing any forest land for habitation or any of their relatives having homestead land in their name. After obtaining in the verification report the follow up action is to be taken. The claimants are to produce one affidavit that they have no homestead land or Cultivation land in their name or in their name of any other member of his/ her families, sharing a common mess.

The Tahasildar, Nilgiri and Oupada are instructed to be liberal for issue caste certificates to ST students on verification of titles issued under the Forest Right Act observing all formalities.


The WEO, Oupada and Nilgiri are directed to co-operate with Forest and Revenue Department authorities to expedite the joint verification work and complete within stipulated time.


