# Green signal to Forest Rights Act by State High Court

Orissa High Court has vacated its interim stay order passed on 23<sup>rd</sup> July 2008 in a writ petition filed by Society of Retired Forest Officers, Orissa

Here it needs to be mentioned that the Society of Retired Forest Officers, (SoRFO) Orissa filed a Writ Application on 30<sup>th</sup> March 2008 urging the court to quash the Forest Rights Act, 2006.

On 1<sup>st</sup> July 2008 SoRFO filed a Misc. Case No. 4540 praying the court to issue interim stay on the Act which was rejected by the court

After this the SoRFO filed another Misc. case No. 10825 on 27<sup>th</sup> July 2008, where State High Court passed interim order not to issue patta and alienate any forestland or fell any tree particularly from National Parks, Sanctuaries and Biosphere Reserves until further order.

This interim order created confusion at implementation level and the process of identification of claims was affected. This fact was pointed by the tribal groups who had intervened in the matter. In response to this the court issued a clarification on the interim order on 2<sup>nd</sup> Sep 2008 with a modification that the interim order has put a stay only on issuing of titles but not on the process of recognition of rights. Court accepted the plea and fixed 16th July 09 for hearing 16th July 09: Hon'ble Judges heard the argument on vacation from the State and Central Govt and other opposite parties and also went through the AP High Court order Writ Petitioner opposed the vacation petition and requested the court not to give any order as the matter is going to be heard at Supreme Court on 4th August 09 Court reserved the order 12th August 09: Court vacated the interim order and allowed the State to issue certificate of titles as per the Forest Rights Act with a condition that titles shall be subject to the final decision on the main Writ Petition.

court passed order on 12<sup>th</sup> Aug vacating the stay order and permitting the State Government to issue titles.

According to a senior official of the State, Government is planning to distribute title deeds from 15<sup>th</sup> August 2009. As per the statistics given by the ST & SC Development Department as on 8<sup>th</sup> June 2009, Gram Sabha has received 2,88,348 individual claims and 1432 community claims of which 31871 individuals claims & 51 Community claims have been finalized by District Level Committee in 26 districts and rest of the claims are in the process of field verification.

The latest monthly progress report released by Ministry of Tribal Affairs on Status of Forest Rights Implementation mentions that at the end of 31<sup>st</sup> July, the District Level Committee has approved around 36892 number of claims of which 36792 is individual claims and 100 is community claims. However, this order of the State High Court is going to benefit more than 1.5 crore population in the State, whose land and rights have been taken away by the colonial government in early 19<sup>th</sup> century.
